3. Minutes of Previous Meeting:

4. Matters arising:

- e. Funding request for new defib. Was not successful. Colin approaching Scottish Sea Farms next.
- f. Hall painting and BBQ 29th June. Very successful event as far as the work went. Great help from Eric T., Julian and Carol W., Stuart R., Dirk, and some of our own hall committee members. No takers for the BBQ by the public so we decided to donate food to the workers. Back of hall, south gable front to be painted next year.
- g. The new Hall Environmental policy, as formulated by ET and posted on the hall Facebook page was unanimously adopted and will now form part of the Hall's formal documentation.
- h. Kitchen. RDS wrote to Gill Law (Trust liaison person for funding) regarding funding for an upgrade to the hall kitchen. Suggestion was that we get a clear mandate and brief of what it is we and the island want from a hall kitchen so that this can proceed.
- i. Art show (9th-16th August) rota lightly arranged with all members of the Board sharing the setting up manning of the exhibition, opening and closing, selling and serving teas, coffees, cakes and sandwiches, taking down and cleaning. Some members of the community offered to bake. Artists to do their own rota of who would be there to host also.

- j. Sport and raft race dance was a trouble free happy event raising £679.39 for the hall.
- k. Alcohol sales in the hall are now possible with the sellers holding the appropriate permissions and license from the Council for each event. Licence to be inspected by two members of the board prior to each event. It would need to be visible at the time the event takes place.
